

2017 Wild Card Reining Challenge Terms & Conditions

GENERAL EVENT CONDITIONS

1. STABLING

The stalls at the South Point Event and Equestrian Center are treated with SynBioNt, www.synbiontagwash.com, after every equestrian event for the protection of your horses and for your peace of mind. Stalls will be available starting at 8:00AM Saturday, May 20th and are based on availability with priority given to sponsors of the event. See Stall Reservation Form for rates. There are no Haul-Ins allowed! All horses attending the event must have a stall. No refunds on stalls after May 15th. Move out is **REQUIRED** by Sunday, May 28th at 10:00AM. Stalls payments must be submitted to the WCRC Stall Manager. No stall payments will go on show bills! If stall fees are included in one check with entry fees the check will be applied toward stalls only. Stalls are not guaranteed unless paid in full. At the completion of the event, any show credits will be issue a reimbursement check within 45 days. The South Point Event and Equestrian Center restricts the use of refrigerators in horse stalls. **ABSOLUTELY NO FEED OR BEDDING MAY BE STORED IN BARN ASLES OR THE ENDS ON BARN ROWS. THIS IS A FIRE MARSHALL REGULATION AND IS SUBJECT TO FINES IMPOSED BY SUCH!**

2. PHOTOGRAPHERS/VIDEOGRAPHERS

No outside video or photography is allowed. Competitors are encouraged to purchase videos and photos from the official show videographer and images from the official photographer. By way of entry into the event, competitors, and their respective employees, agents and family members grant the permission without remuneration for the use and public distribution of their image, likeness, voice and video for the possible promotion of the event. All exhibitors will be subject to the use of photographers and videographers under the direction of show management for the benefit of show promotion. No exhibitor will be allowed the discretionary use of his or her services. **ONLY THE OFFICIAL EVENT PHOTOGRAPHER WILL BE ALLOWED TO SELL PHOTOGRAPHS OF THE WILD CARD REINING CHALLENGE HORSE SHOW.** All images pertaining to or in relation to the Wild Card Reining Challenge Horse Show are under the sole ownership of Wild Card Reining Challenge/HRRRC, Inc. Only event management approved reporters assigned by recognized newspapers, radio or television or the Associated Press will be issued press passes. Requests for press passes **MUST** be sent in writing, faxed to 623-670-5905, or e-mailed to brumleymanagementgroup@gmail.com, on the letterhead of the newspaper, magazine or broadcast outlet and signed by the editor. All other photographers must sign an agreement not to sell their photographs except to the publications for which they work two weeks prior to the beginning of the show. Photographers who have not followed these requirements will be escorted off the grounds.

3. DAMAGE

Individuals will be responsible for any physical damage inflicted to the South Point Event and Equestrian Center property and will reimburse the show management for such damage as it may be charged. All owners and exhibitors shall be responsible for any damage incurred by them, their agents or employees to stalls, buildings, and other properties on the show grounds and shall be billed accordingly.

4. HEALTH REQUIREMENTS & CERTIFICATES

Health requirements for the State of Nevada and the South Point Event and Equestrian Center will be followed. A 30-day health certificate and 12-month Coggins are required upon arrival. This includes horses that reside in the state of Nevada. Papers must be submitted to show office at check in.

5. LIABILITY

By participating in the Wild Card Reining Challenge, all competitors agree to abide by the rules of the show and the governing body NRHA. In addition, acknowledge that horses are dangerous animals and can be hazardous. By participating in the competition with this knowledge of the danger involved the competitor agrees to accept any and all risks of injury or death.

6. RULES/CHANGES

The Wild Card Reining Challenge and Brumley Management Group LLC, reserve the right to make additions or changes to this event at any time. Show management has the authority to enforce all rules referring to the show and may excuse any horse or exhibitor from the show prior to, during or after the judging without refunds. **SHOW MANAGEMENT RESERVES TO ITSELF THE RIGHT TO REFUSE, ACCEPT CONDITIONALLY, OR TO CANCEL ANY ENTRIES, DISQUALIFY ANY RIDERS OR EXHIBITORS, PROHIBIT EXHIBITION OF ENTRIES AND CANCEL AWARD PRIZES, WITHOUT CLAIM OF DAMAGES.** The show management reserves the right to interpret these rules and regulations. All decisions are final. By way of making an entry, the exhibitor is assuming responsibility for knowledge of the rules and releases show management from any claims or losses. The show management reserves the right to modify or change conditions for the Wild Card Reining Challenge event at any time. All decisions of the judges are final.

7. RIGHT TO CANCEL

The show management reserves the right to cancel the event without notice at any time prior to the contest and without liability to the show management. In the event of such cancellation, entry fees or other show fees paid in advance shall be refunded. The show management reserves the right to itself to interpret all questions and conditions in regard to, or arising out of, or incident to, the show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by show management, its decision to be final. Every horse entered herein for competition will be under control of the show management, but the show management will in no case be responsible for any loss or damage that may occur and it shall be a condition of entry that each exhibitor shall hold the Horse Show, officials, employees, Directors, Sponsors and the South Point Event and Equestrian Center blameless for any loss or accident to horse(s), employees or equipment.

8. SECURITY AND PARKING

The South Point Event and Equestrian Center provide monitored security in all areas of the Event Center, Casino, and Hotel. Access to the equine stabling and warm up areas is restricted to those individuals who participate in the event and are provided Wild Card Reining Challenge Barn Access Passes. **These passes must be worn at all times to enter these areas.** Nighttime access to the barns is limited. South Point Security must be notified to gain vehicle access to the stabling areas with a vehicle after event hours. The South Point Event and Equestrian Center has designated specific areas to park trucks and trailers. It is required that all trailers be parked in designated parking areas only.

9. DISCIPLINARY PROCEDURES

FAILURE TO PAY: Any fees associated with the entry of a horse in the Wild Card Reining Challenge, including but not limited to entry fees, administrative fees, stall fees, sponsorships, etc. which are not paid in full within 30 days of the close of the event will result in owner of horse or sponsor's immediate suspension from competing in or participating in any further Brumley Management Group, LLC events until amount owed and any late or NSF fees are paid in full.

BEHAVIOR, CONDUCT AND ANIMAL WELFARE: Any action of disrespect, deceit, slander or fraud directed to the event, show management, grounds crew, show representatives, sponsors or judges will result in disqualification from competition and removal from the facility. No entry, administrative fees or stall refunds will be provided. Individuals accused of unsportsmanlike conduct will be subject to the disciplinary procedures set forth by the National Reining Horse Association in Article A of the handbook. Anyone found to be abusing animals

will be disqualified and reported to NRHA. **IN ADDITION, THESE INDIVIDUALS WILL BE SUSPENDED FROM PARTICIPATING IN ANY BRUMLEY MANAGEMENT GROUP, LLC EVENTS FOR A MINIMUM OF ONE YEAR.** Reinstatement of the right to exhibit is based on review by BMG production and show management.

SCHOOLING HORSES DURING COMPETITION CONDITIONS

Competition guidelines for exhibitor schooling:

Every competition class offered at this event is broadcast LIVE over the internet to the WORLD. In an effort to maintain the integrity and professional appearance of the event, all exhibitors choosing to enter COMPETITION CLASSES to school horses, **MUST** present these horses in show attire. Show attire is defined as; exhibitor's entry is required to present their horse with a show pad, clean tack, and the horse's tail must be down (not braided or up in a tail bag/sock). It is requested by show management that the rider wear show chaps. As per NRHA Attire Guidelines, a long sleeve shirt, western hat and boots are required. The Equipment Judge located at the back gate of the show arena will enforce this guideline.

Show management requests that if you intend to "school" a horse entered in a competition class that you DESIGNATE your intention to do so. A form will be available to you, for this purpose, in the show office. When entering a class to school, fill out the 'Designation to School Form' and submit it to the show office upon entry. These designations will be drawn separately from the regular competition class. This "Designated Schooling Draw" will go after the competing entries. If an exhibitor schools their horse in the regular competition draw, the judge may ask the exhibitor to leave the arena.

10. MATURITY ELIGIBILITY REQUIREMENTS:

The Maturity divisions are for horses 7 years of age and older as of the start of the calendar year. Arabian and Half Arabian Maturity divisions are for horses 6 years of age and older as of the start of the calendar year. Arabian & Half Arabian Maturity divisions are for horses 6 years of age and older.

11. NRHA MATURITY AND ANCILLARY DIVISIONS PRE-REGISTRATION: (Must be received by April 23rd)

Submission of completed Entry Form, one per horse, NRHA Competition License and Owner/Rider current NRHA Membership cards, and signed Participation Liability Release must be received by April 23rd, for entry to be considered complete and avoid the \$85 Post Registration Fee. **A form of payment will be required to check in and receive your number at the show office. DO NOT MAIL ENTRIES IF THEY WILL BE RECEIVED BY SHOW MANAGEMENT AFTER MAY 15TH!**

Maturity and Ancillary division post entries will be accepted until 3:00pm the day BEFORE the class is to take place. An ADD Card must be filled out in the show office for all added classes prior to deadline. A SCRATCH Card must be filled out in the show office for all scratched classes. **NO CHANGES WILL BE TAKEN AT THE BACK GATE.** Classes scratched PRIOR to the draw being posted will receive a refund of entry and judges fee.

12. 4 YEAR OLD FUTURITY ELIGIBILITY REQUIREMENTS:

The 4 Year Old Futurity has been created to offer young horses more time to receive the training they need to start their competition careers. With this goal in mind, to be eligible to compete in the WCRC 4 Year Old Futurity, horses must be 4 years of age as of the start of the calendar year and cannot have been shown in **ANY** Age Event Competition/Futurities as a 3 Year Old. These horses are allowed to be shown in AQHA, NRHA or NRCHA events to receive the show seasoning required as part of the training process as long as the NRHA Category 2/Futurity Aged Event restrictions are followed. Riders are required to enter up at least one level from the lowest level qualified. Horses may cross enter into the 4 Year Old Stakes with only one judge's fee applicable. All entry fees apply.

13. 4 YEAR OLD STAKES ELIGIBILITY REQUIREMENTS:

The 4 Year Old Stakes has been created to offer young horses the chance to compete against horses the same age. Horses must be 4 years of age as of the start of the calendar year. Riders are required to enter up at least one level from the lowest level qualified. Eligible horses may cross enter into the 4 Year Old Futurity with only one judge's fee applicable. All entry fees apply.

14. FUTURITY AND STAKES PAYMENT DEADLINE (Must be received by April 23rd)

FUTURITY: Level 4 OPEN, Level 3 OPEN, Level 2 OPEN, Level 1 OPEN and Level 4 NON PRO, Level 3 NON PRO, Level

2 NON PRO, Level 1 Non PRO. Entries are required to enter up one division from the lowest division qualified for. **PRE-ENTRY REQUIREMENTS:** Submission of completed Entry Form, one per horse, NRHA Competition License and Owner/Rider current NRHA Membership cards, signed Participation Liability Release, and form of payment must be received by April 23rd, for entry to be considered complete and avoid the late fee assessment. For entries that are faxed, there must be WCRC Credit Card Authorization Form included to at least hold the entry. If holding with a credit card, please write HOLD by the credit card info and mail a check immediately. **Post entries will be accepted until 3:00pm the day BEFORE the class is to take place. DO NOT MAIL ENTRIES IF THEY WILL BE RECEIVED BY SHOW MANAGEMENT AFTER MAY 15TH!**

FUTURITY AND STAKES HORSES MAY BE SHOW ONE HANDED IN A SHANK BRIDLE OR TWO HANDED IN A SNAFFLE BIT OR HACKAMORE.

15. 4 YEAR OLD FUTURITY AND STAKES LATE ENTRIES

Late entries for the Wild Card Reining Challenge Futurity Aged Event Divisions, Open and Non Pro, will be accepted with the following late fees:

RECEIVED after April 23rd - \$200 one time late fee assessed, plus all entry fees payable at the time of entry. **Post entries will be accepted until 3:00pm the day BEFORE the class is to take place. DO NOT MAIL ENTRIES IF THEY WILL BE RECEIVED BY SHOW MANAGEMENT AFTER MAY 15TH!**

16. DESERT REINING HORSE ASSOCIATION (DRHA) ROOKIE & GREEN DIVISION ELIGIBILITY

DRHA ROOKIE ELIGIBILITY (NOT NRHA APPROVED) is an entry level III division.

For Non Pro, Youth, and Amateur riders with less than \$250 lifetime reining or reined cow horse earnings (from any and all shows, NOT limited to NRHA earnings) Riders must compete on a horse owned by them as defined in the NRHA handbook.

DRHA GREEN AS GRASS ELIGIBILITY (NOT NRHA APPROVED) is an entry-level II division.

For Non Pro, Youth, and Novice Amateur riders with less than \$200 lifetime reining or reined cow horse earnings (from any and all shows, NOT limited to NRHA earnings) who have earned less than 50 NRHA Youth points, and/or less than 20 AQHA or ANY Breed or Club Associated reining or reined cow horse points at the beginning of current show year. Class will be jackpotted. Green As Grass Reiner points will count toward year-end awards. An eligible Green As Grass Reiner can compete in the division for the entire calendar year even if their earnings exceed the limit during the year.

DRHA GREEN REINER ELIGIBILITY (NOT NRHA APPROVED) is an entry-level I division.

For Non Pro, Youth, and Novice Amateur riders with less than \$100 lifetime reining or reined cow horse earnings (from any and all shows, NOT limited to NRHA earnings) who have earned less than 20 NRHA Youth points, and/or less than 10 AQHA or ANY Breed or Club Associated reining or reined cow horse points at the beginning of current show year. In addition, rider cannot have won ANY Year-End Reining or Reined Cow Horse Award. Class will not be jackpotted and no prize money will be paid out. This is an award division only. Green Reiner points will count toward year-end awards. An eligible Green Reiner rider can compete in the division for the entire calendar year even if their earnings exceed the limit during the year.

17. FEES

Each horse entered in the event will be assessed a one-time Administration Fee of \$85, a Video Fee of \$25, and Photo Fee of \$25. Exhibitors who do not check out their accounts prior to their departure will be charge a one-time fee of \$15 to close out their open check or credit card and mail receipt statement. **There will be no charge for video viewing of exhibitor runs during the event.** *With the increase of on demand electronic media, photo and video companies are losing income at events and jeopardizing their businesses. Since NRHA requires all AA Event classes to be video recorded, these fee goes directly to pay for video services and photography expenses at the show.*

18. REFUNDS

After May 15th, cancelation of a Futurity Entry will receive a refund of entry fees with submission of veterinary certificate stating the horse is unable to compete due to health reasons. The Administration Fee of \$85 is non-refundable. Horses may be substituted, based on management's discretion. Ancillary divisions will receive a refund of their entries if the divisions are scratched prior to the draw taking place. The Administration Fee of \$85 is non-refundable. Stalls are not refundable after May 15th. **NO REFUNDS ONCE THE CLASS DRAW HAS BEEN POSTED.**

18. PRIZE MONEY & HIGH POINT TROPHY SADDLES

4 YEAR OLD FUTURITY & STAKES DIVISIONS: The Wild Card Reining Challenge will retain 35% of each division entry fee collected. NRHA requires 5% of total entry fees made payable to them. The remaining **60% will be added to the division's overall purse.** NRHA payback Schedule B percentages utilized and will be based on the number of eligible entrants in each division.

MATURITY DIVISIONS: The Wild Card Reining Challenge will retain 50% of each division entry fee collected. NRHA requires 5% of total entry fees made payable to them. The remaining 45% will be added to the division's overall purse. NRHA payback Schedule B percentages utilized and will be based on the number of eligible entrants in each division.

ANCILLARY DIVISIONS: The Wild Card Reining Challenge will retain 50% of each division entry fee collected. NRHA requires 5% of total entry fees made payable to them. The remaining 45% will be added to the division's overall purse. NRHA payback Schedule A percentages utilized and will be based on the number of eligible entrants in each division.

HIGH POINT TROPHY SADDLES: In the instance where there is a tie for Champion in multiple High Point Divisions with saddles, as in Rookie 1, 2 and Prime Time Rookie, saddles will be divided between winners equally instead of flipping a coin. This allows for tied parties to receive a trophy saddle. If there are more than two exhibitors tied to win High Point Saddles, management will decide a fair way to break the tie.

AWARD PAYOUT CHECKS will be mailed once management receives NRHA approval of results. If NRHA does not return approved results to show management within 40 days after the last day of the event, checks will be mailed out to abide by NRHA's 45 day payout rule requirement. If checks are mailed out prior to show management receiving NRHA result approval, Wild Card Reining Challenge/HRRC, Inc. and Brumley Management Group, LLC will not be held liable for any prize money or awards not returned to show management by those who are disqualified by NRHA. Those who fail to provide payment for outstanding invoices or return disqualified prize money within 10 days of being notified will be SUSPENDED from any further Brumley Management Group, LLC events and reported to the NRHA for disciplinary procedures. Any outstanding balances owed will be deducted from payouts. Returned checks will be charge a \$50 NSF Fee. Remaining balances will have 10 days to provide payment in full via cashier's check or credit card (including credit card fee of 5%). Payments not received within the designated time may incur penalty fees.

19. SUBSTITUTIONS

Substitutions/transfers of entries will be permitted prior to the draws being posted, based on management's discretion.

20. DRAWS

In the instance where there is a group of classes of substantial size, management reserves the right to adjust the draw to allow riders with multiple entries the maximum number of horses possible between draw positions. This is to allow riders adequate time to prepare their horses in a safe and effective manner.
